Tuition Due Dates

The monthly discount tuition for childcare is due in advance by the 5th of each month; prior to the month childcare is being provided to avoid late charges. Parents paying bi-monthly must pay the second portion by the 18th of the month to avoid late charges. A late charge of \$5.00 per day will be charged after the 5th and 18th. Those more than 3 days past due will not be allowed to attend care until payment is received Drop-Ins will pay daily. Monthly rates are based on reserving your child’s spot at Olympic View. **All Tuition rates are due regardless if your child attends care or not.**

Also, parents paying weekly MUST pay on the first day of care during that week, or a \$5.00 late charge will be assessed for everyday, with no care provided if past 3 days late.

NSF Checks

There will be a \$35.00 charge for all checks returned by the bank. The NSF charge and the amount of the check must be paid before childcare is continued, unless special arrangements have been made with the director. After 2 NSF checks, only cash payments will be accepted.

Overtime Charges/Late Fees/After Hours

You are subject to overtime charges if your child is here before or after their scheduled hours unless you have given one weeks written notice to the daycare office and the director has approved it. Hourly overtime charges are; \$7 per hour for infants, \$6 per hour for toddlers, and \$5 per hour for children over 30 months.

After 6:30 p.m., there will be a charge of \$5.00 per family and an additional charge of \$1.00 per minute, per child. If your child is not picked up by 6:40 p.m., we will attempt to contact someone from your emergency contact list. If no one can be reached, OVCDC may call Child Protective Services. When a child has been picked up after 6:40 p.m. 3 times, childcare will be terminated.

Early Dismissal and Non-School Days

There is a flat fee of \$20.00 per child for early dismissal days and a flat fee of \$25.00 per child for non-school days.

Transportation

Transportation by OVCDC is available to and from North East Tacoma Elementary and Browns Point Elementary schools. There is a transportation charge of \$25.00 per month per family

Family Discounts

There is a 15% discount for the second child enrolled from the same family. The discount is taken off the lower rate. There is no third child discount.

Schedule Changes/On Call Days

Parents must submit all schedule changes in writing two weeks in advance for approval by the director. On call days are a day that was not scheduled two weeks in advance and is subject to a higher daily rate. On call days are subjected to availability of space.

Preschool

OVCDC offers a preschool program designed for children ages 3 years to 5 years. Children enrolled in these classes must meet the age requirements for their class. Children enrolled in preschool must be the required age for their class by September 1.

A 2 week notice is required for terminating care to receive proper credit. Otherwise, parents will be billed as scheduled for 2 weeks.
